*The below list of regulations are for the safety of the observer and the host Officer.*

1. Observer will act only under the direction of the host Officer.
2. Observer will not leave the squad car at the scene of any police activity.
3. Observer will not converse with prisoners, suspects, witnesses or other parties contacted on police business unless requested by the Officer.
4. Observer will not handle evidence.
5. Tape recorders, cameras and video equipment are prohibited.
6. Observer is encouraged to ask questions regarding procedures and activities, but it must be done at the appropriate time.
7. At no time will the observer be permitted to enter a crime scene.
8. In order to comply with Department policies, you must wear your seat belt in the police vehicle at all times.
