† Board of Trustees do not hold regular meetings on the Fourth Tuesday of the months of June, July, August or December.

†† If the Village Board CONCURS with the recommendation of the Planning & Zoning Commission, approval of the ORDINANCE / RESOLUTION in most cases will be on the next following Village Board meeting.
